- a. Baltimore Grotto Moved, Blue Ridge Grotto seconded:
 - M) The NSS shall provide server space for grottos and regions to post pictures and/or stories about cavers who have passed on. Collecting and submitting the material for posting would be the responsibility of the I/O's.

Several regions are already maintaining a list of fallen cavers. Given the NSS is a national organization we should be providing a space where all members have access to this Hall of Fame.

The entire membership shall be sent notices as to the date, place, and purpose of any such meetings at least two weeks in advance thereof.
